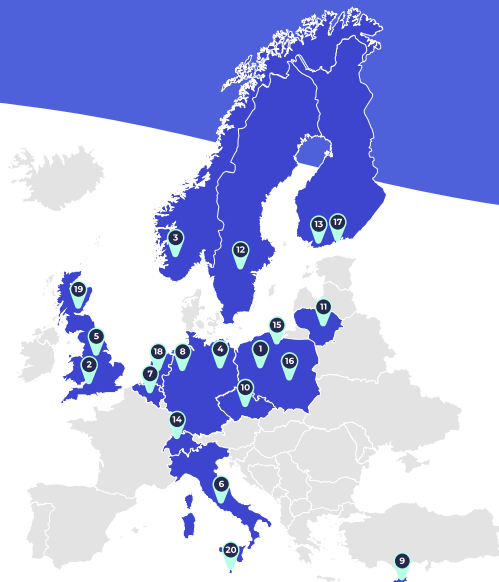

## 2PS GOALS

### • Enhancing prevention

Ensuring resources are available to various target groups of people who fear that they might offend against children helping to prevent them from acting on their thoughts and avoid children from harm.

### • Increasing efficacy of prevention

Establishing good practices and helping to review and evaluate the actions that can help deter people from offending. Moreover, amplifying the services and support actions available to target groups by establishing a central repository of prevention actions. Increasing capabilities and competency across Europe by providing the latest training for frontline staff, LEAs and specialist therapists.

### • Raise awareness

Prevention is better than the cure. We must reduce barriers to treatment and minimise stigmatisation to encourage people to seek support, and for the public to acknowledge the significance of prevention. Raising awareness is a critical step for fighting child sexual abuse but also for illustrating the value of prevention as a tool for reducing harm to children.

## 2PS – Helping to prevent child sexual abuse and exploitation.

Prevent and Protect through Support (2PS) is an EU funded project (2022-2025) that brings prevention to the forefront aiming to prevent harm to children before it occurs. 2PS is offering a paradigm shift in the approach to tackling child sexual abuse and exploitation (CSAE) across Europe.

This project will provide experts with a better understanding of what leads to harmful behaviour while informing and educating people who fear they might offend against children about the support services and rehabilitation options they have. Further, 2PS will produce and share the best practices for guidance, therapy and treatment methods with essential stakeholders.

### 2PS objectives



Develop culture-sensitive policy recommendations on child sexual abuse prevention methods applicable throughout the European Union.



Increase awareness among people with sexual interest in children on available support services to prevent offences.



Increase knowledge on individuals with sexual interest in children and the need to guide them to behavioural change in order to prevent offending.



Enhance prevention actions by developing training materials for LEAs and frontline staff, networking among stakeholders and conducting awareness campaigns.



Share policy recommendations on how to enable prevention methods across the European Union that address the challenges of sociocultural divisions and approaches.
